

An Interview With William S. Burroughs

As a buildup to The Anchor's 75th birthday, this newspaper will be publishing 'classic' Anchor pieces that document the rich history of the organization

William S. Burroughs is perhaps one of the most complex, diverse and controversial of modern writers. In order to understand his works, one must leave behind all the old conceptions of literature and the old modes of thought. Burroughs has been much misunderstood and maligned by critics and so-called "students of literature" in recent years, but with the world being in the situation that it is these days, many are finally waking up to the fact that he is not, and never was, off the track at all. It is difficult to explain Burroughs to those who do not take to either his literary style or to his message. It is a bit like speculating on the existence of God with a "true believer"; set ways are set ways, and more's the pity.

Burroughs' first work, Junkie, was published in 1953 and it concerns Burroughs' life as a heroin addict in the United States and Mexico. Written at the urging of Allen Ginsberg and Jack Kerouac, both of whom Burroughs befriended while the two were students at Columbia

whom Burroughs befriended while the two were students at Columbia University, *Junkie* is a frank and realistic narrative. The book, which University, Junkie is a frank and realistic narrative. The book, which is only a thinly veiled autobiography, was written under the pseudonym of William Lee, a character who has since appeared in most of Burroughs' later works. The "novel" begins in New York City around 1945, when Burroughs first started taking heroin. Burroughs maintains that addiction is an "illness of exposure," and since he was able to get morphine at that time he gradually became hooked. For the next fifteen years, eight of which are covered in Junkie, Burroughs' life revolved around opiates. In Junkie, one can see the seeds which were later to grow into such novels as Naked Lunch, Nova Express, The Ticket That Exploded, and others.

Burroughs also wrote another work, Queer, immediately after Junkie, but this remains to be published. Queer was an extension of Junkie, recounting Burroughs' adventures in Mexico.

From Mexico, Burroughs trayeled down through South America in a holy grail type search for Yage, a drug of supposed telepathic powers which, for Burroughs, offered the possibility of what he termed "the final fix." (At the end of Junkie, Burroughs wrote: "Yage may be the final fix.")

During the time he traveled in South America, Burroughs corre-

During the time he traveled in South America, Burroughs corresponded frequently' with Allen Ginsberg, and from this correspondence came *The Yage Letters*, in which are the beginning "routines,"

RIC Records Office Closing Early for Spring Semester

Beginning the third week of spring se-mester, a change in schedule will be insti-tuted by the Records office at Rhode Island

tuted by the Records office at Rhode Island College.

Students who expect to be able to change billing addresses, order transcripts, add and drop classes, pick up a course catalog and do many other errands, will be unable to receive service after 4:30 p.m., which is when the office will be closing Monday through Friday.

The Records office will remain open until 7 p.m. during the first two weeks of spring semester only. However, by the start of week three, as well as the third week of every subsequent semester. Records will be

Recently, Gov. Lincoln Almond announced a state reduction of expenditures. Consequently, President Nazarian sent a memo to all Vice-Presidents, Deans, Department Chairs, and directors of the college informing them that, "the state is an-

ticipating a significant shortfall revenue for

the current fiscal year."

James Dorian, Acting Director in the Records Office, explained that because of this budget difficulty RIC Administration asked, "How can we save money—and keep anyone from being laid off." Thus, Records decided an earlier closing time would be beneficial to help with reduced spending.

Eleven people are employed in the Records office, working full-time hours. Keeping someone at the office until 7 p.m. required overtime workers and overtime

pay.

Jeanne Boichat, an employee at the Records office said in the past there was specifically an evening shift from 11 a.m. until 7 p.m., but then employees working overtime replaced that position. Now that closing time will be 4:30 p.m., overtime will be extinguished

Providence to Host 2001 Pan-Am Intercollegiate Chess Championships

The 2001 Pan-Am Intercollegiate Chess Championships will be held December 26-29, 2001, at the Providence Marriott in Providence, 2001, at the Providence Marriott in Providence, Rhode Island. The event is being sponsored by the Rhode Island College Chess Club in conjunction with the US Chess Federation, and will attract teams from the United States, Canada, and South America. The total prize fund is \$2600, which will be divided among the top five teams. The Pan-Am Intercollegiate Chess Championships is the largest collegiate chess tournament in the western hemisphere, and awards a USCF recognized national title. This will be the third time that Providence has played host to the event (1986, 1994). Rhode Island College won the event in 1985.

Also taking place will be a Scholastic tour-

Also taking place will be a Scholastic tour-nament for high school, middle school, and ele-mentary children. The top high school finisher will be awarded a 4-year tuition and fees scholar-ship to the University of Texas - Dallas, last year's

PanAm co-champions (University of Maryland - Baltimore County). There is an Open tournament as well, for which any player is eligible. Two-Time United States Champion, 2001 FIDE World Championship participant, and RIC Chess Club coach Larry Christiansen will be giving a simultaneous chess exhibition at 2:30pm on Wednesday, 12/26, and will also provide analysis of games for free during the tournament. 



Dorian believes that by closing early, all 11 employees will be able to hold their jobs and continue to work full-time.

which were later expanded and added to by Burroughs and then incorporated into Naked Lunch. The Yage Letters also describe Burroughs' discovery of yage, which he found to be far from "the final fix."

After spending several years in South America, Burroughs went to Morocco in a state of complete addiction to opiates. He lived there in a small, dirty, underground apartment in the native quarter of Tangiers, where his main activity was keeping up his habit. For excitement, he would be accessionally do target practice on occasionally do target practice on a wall of his room with a pistol, but the majority of his time was spent in staring at the tip of his shoe for hours at a time, sitting, in his own words, as "inscrutable as a turd." For the most part, he sel-dom went out for any other reason

than to cop more junk.

"Stasis" went on until Burroughs could not afford his habit, which was growing monstrously, even in a cheap and drug-laden country like Morocco. He had tried a wide variety of cures, none of which had any lasting effect. Finally, he was at the end of the line. At this time, he has said, "I wasn't doing ANYTHING. I was dead." In a life or death decision, Burroughs took what little money plane to London to take the "apo-morphine cure," under the super-vision of Doctor John Dent. This cure, which involves the injection of apomorphine to offset the ef-fects of withdrawal, was administered to Burroughs in a London nursing home. Miraculously, or so it must have seemed, Burroughs walked out eight days later a cured man. "that usually takes at least a month with other cures, had been accomplished in a little more than a week with apomorphine, a drug which is produced by boiling mor-

phine with hydrochloric acid.
This cure left an indelible im-

pression on Burroughs because of the simple fact that it worked. In the following years, Burroughs re-lapsed only twice, and quick ad-ministration of apomorphine cured him. Burroughs has attempted to interest a number of concerns in this country with the apomorphine cure, which he has seen work, time and time again, seen work, time and time again, on many addicts and alcoholics, but no one was, or still is, interested: (Even the Federal Narcotics Hospital in Lexington, Kentucky, has consistently refused to try it, on the grounds that it is too "dangerous" - a charge it is too "dangerous" - a charge which Burroughs labels as ludi-crous. This is indeed strange, concrous. This is indeed strange, considering the blather one sees and hears in the media about "every possible means" being employed to cope with and stem the drug problem in this country. The "every possible means" which they talk about, often boils down to a jail sentence or its clinical equivalent.) Such official disinterest has led Burroughs to conjecture that, perhaps federal and jecture that, perhaps federal and state narcotics agencies DO NOT

WANT a reliable cure.

In the late fifties, as he emerged from the junk world, Burroughs put together a series of notes and routines which he had written during the worst due of written during the worst days of his addiction, and published them under the title suggested to him by Jack Kerouac: Naked Lunch. This satirical work contains fantasies so wildly horrible, but humorous, that one wonders how Burroughs could have made such incredible. could have made such incredible perversity so overwhelmingly funny. How could anyone laugh at such things' Well, the answer may be because it is all so familiar. Burroughs does not deal with any universal "truths" or "absolutes" in Naked Lunch; he has just put down, in a form that is not that exaggerated, much of what exists around us but which we re-

Naked Lunch is a vast panorama of shams in every field of endeavor. Political parties devoted to control and Big Brother takeover, bigoted sheriffs, utter

shams of doctors (especially the most fraudulent of all: Doctor Bensay), completely unscrupulous businessmen (such as Salvador Hassan O'Learv, the afterbirth tycoon), drug addicts and dealers, dishonest cops, a strange species, like the Latahs (people afficied with a disease which comflicted with a disease which com-pels them to imitate the actions of those around them), the mug-wumps (creatures too horrible to wumps (creatures too horrible to describe), and so on. Most of Naked Lunch takes place in the City of Interzone - a horrible but familiar place, which Burroughs describes as "the Composite City where all human potentials are spread out in a vast silent market."

In Tangiers, Burroughs met Brion Gysin an English painter.

Brion Gysin, an English painter and writer who suggested to Burroughs the application of painting techniques, such as collage and montage, to writing. This led to the "cut-up technique" of writing, which Burroughs has since pio-neered in his own works. Cut-ups are best described, as it was first formulated, in Gysin's article of 1959 - Cut-Ups Selfexplained:

"Writing is fifty years behind painting. I propose to apply the painter's techniques to writing; things as simple and immediate as collage or montage. Cut right through the pages of any book or newsprint ... lengthwise, for ex-ample, and shuffle the columns of text. Put them at hazard and read the newly constituted message

the newly constituted message ...
... Poets are supposed to liberate words - not to chain them in phrases. Who told poets they were supposed to think? Poets are supposed to think? Poets are meant to sing and to make words sing. Poets have no words of "their very own." Writers don't use their words. Since when do words belong to anybody? "Your very own words," indeed! And who are you? "

Burroughs, Gysin, Gregory Corso and Sinclair Beiles applied this technique to several works and published the results in a pam-phlet entitled "Minutes to go" in Paris in 1960. A subsequent pam-

phlet of the cut- ups came out in the United States, entitled Exter-minator featuring cut- ups by Bur-roughs and Gysin. The technique quickly achieved notoriety. (as Burroughs states, the technique is not actually all that new. Tristin Tzara, an early twentieth, continue Tzara, an early twentieth- century surrealist, experimented with the random composition of poems by pulling words out of a hat. He once puting words out of a hat. He once proposed to do this at a convention of writers in a Paris theater, and the madness that ensued rivaled the premier of Stravinsky's Rite of Spring in 1913.)

In his next three works, The Ticket That Exploded, Nova Express and The Soft Machine, Burroughs the cut, and the spread of the soft machine.

press and The Soft Machine, Burroughs the cut- up technique to a great extent; but these works, as all of his works, in fact, are not as random as they seem. Using a science fiction style as a vehicle, Burroughs again satirizes many facets of American life. He extends many of the themes in Naked Lunch into a setting, which comprises much of the known universe. The "Nova Moh" in Nava verse. The "Nova Mob" in Nova Express always aggravates the situation, desiring to keep it ever in a state of turmoil while the "Nova Police" move in on the situation, take care of it, and then quickly leave. But in Burroughs' world even the "Nova Police" are suspect, as even they have a tendency to get out of hand.

In Burroughs' next two works, *The Wild Boys* and *Exterminator!*, he demonstrates the effects of the failure of control, a theme he had worked with extensively in his four previous books. The Wild Boys is set in the future where the world is completely taken over by wild boys - gangs of rampaging youth armed with eighteen inch Bowie knives.

In Externinator!, the chaos comes a little closer to home. Operating in the capacity of externing in the capacity of external content of the content of the

erating in the capacity of "exter-minators" are high-ranking army officials, CIA agents, the Chicago police (one part of the book is set in Chicago during the 1968 Democratic convention), secret-service men, and various other such familiar figures. (For a time towards the close of World War 11, Burroughs worked as an extermi-nator.) In this work, Burroughs ex-tends the exterminator image into a comprehensive metaphor. It is the result of control that has been resisted and broken down; if you can't control the populace, exter-minate it. These exterminators, of course, are easily identifiable forms.

The methods described by Burroughs by which control is carried out have a frightening and familiar ring to them, probably because they're practically the very same methods used by the "Plumbers" and various "national security" agencies. In the light of this, Burroughs' works may be considered prophetic. If so, we are in for a terrifying future.


Despite his warnings, much of what Burroughs has written about has come to pass. What seemed grossly exaggerated and perverse in Burroughs' works during the 1960's is now everyday front-page news. We are now in an age of young, suburban junkies, official tape-recorded blackmail, and police state control Ad Nauseum. If he wished to do so, Burroughs could sit back and justly say, I Told You So.

Many critics have dismissed him for his radical and, to them, his incomprehensible style, and many upholders of "decency" have despised and fought him because of his (whose?) perversity as is usual, many of them got caught up in the particulars while the gist of the matter went ignored. Concerning this opposition, Marshall McLuhan wrote in The Nation, "It is amusing to read reviews of Burroughs that try to classify shall McLuhan wrote in *The Nation*, "It is amusing to read reviews of Burroughs that try to classify his books as non-books, or as failed science-fiction. It is a little like trying to criticize the satirical and verbal manifestations of a man who is knocking on the door to explain that flames are leaping from the roof of the home."

Student Athlete Diaries

As a student-athlete at Rhode Island College I deal with the stress of juggling classes, indoor track practices and a part time job.

I became a member of the indoor track team to stay in shape and to continue my dedication in track (I ran all four years of high school as a sprinter). Being a sprinter on a college team demands tough workouts on a daily basis. The workouts are conducted in a positive environment where the coach and the other runners are supportive of each other.

A typical day for me, after attending classes, is to head to the track around 3:30 in the afternoon. Once the team is all accounted for, we start our warmup. The warm-up consists of a 1/2 mile jog, followed by stretching. After the warm-up we start our drills. The drills consist of three sets of each of the following: high knees, butt kicks, kick-outs straight legs, a backwards jog, moving jumping jacks, up and outs and finally strides. Doing these drills will help improve our coordination and balance. These drills are done everyday before the workouts and usually take about 25-30 minutes.

The workouts differ from week The workouts differ from week to week and day to day. On a typ-ical day, we have around ten sprinters working out. Monday and Tuesday are the toughest days and Wednesday and Thursday are less grueling. Friday is our easiest day as we prepare for our meets. After we are completely done with practice, most of us will head to Donovan Dining Center to grab something to eat and talk about how well we just worked out and prepare for the upcoming meet. Saturday is the day we finally get to compete. The indoor track team doesn't compete during the week; instead we travel to meets around New

England every Saturday.
On Dec. 2, the team competed at the Brown University Invitational, where we competed against Division I teams [RIC is Division III]. Usually, a track meet lasts all day. That is because meet lasts all day. That is because the men and women compete together, but not against each other. Mike Daniels had a great meet for us, placing first overall in the 800 meters. Tim Rudd placed second in the 3,000 meters. Matt Tarpy placed second in the high jump. Finally, the week ends on Sunday, when the team gets together on its own and runs about 3-5 miles.

Being a part of the men's indoor track team is an experience. What I mean is that indoor track practices are very different from

that I mean is that indoor track practices are very different from other sports practices. The mem-bers of the team push each other to work harder each and every day, pushing their bodies to the limit in the process. Chris Puleo is a senior on RIC's
