Hey, College Kids!

When students at Pittsburg State University return to campus this week after winter break, they'll be encouraged to quickly roll up their shirt sleeves.

And get a meningitis vaccination.

The vaccination clinic on Thursday comes after two students were diagnosed last month with the infectious disease. The students, who were never publicly identi-fied, have recovered and suffered no long lasting effects university

fied, have recovered and suffered no long-lasting effects, university officials report. Meningitis strikes about 2,500 Americans each year, leading to death in about 10 percent to 15 percent of cases. Anywhere from 100 to 125 cases pop up annually on college campuses, and five to 15 students die as a result, according to federal health officials. Though cases on college campuses are rare, health officials have cautioned for years that stu-dents living in groups, such as res-

dents living in groups, such as res-idence halls run a higher risk than the general population of contract-ing the disease.

Meningococcal disease, or meningitis, can cause either an inflammation of the membranes around the brain and spinal cord or a serious infection of the blood. It is spread by direct contact with someone infected by the disease _ coughing, sneezing, sharing saliva _ sharing food and utensils, kiss-ing, smoking the same cigarette.

Yes, college student behavior.

Add to that a student's immune system compromised by all-night study sessions, drinking and stress, and the risks become clear.

clear. The symptoms are very sim-ilar to the flu _ fever, headache, neck stiffness, nausea, vomiting _ and can easily be misdiagnosed or even ignored by the infected per-son. To make matters worse, cases f meninging to the final to neak in late of meningitis tend to peak in late winter and early spring, often coin-ciding with the flu season. A Northwest Missouri State

A Northwest Missouri State University freshman died of meningitis two years ago. So Missouri legislators last summer passed a law requiring all students who live in campus housing to sign a written waiver saying that their school has provided them detailed information about the risks of the information about the risks of the disease and availability of the vac-

The new law takes effect this fall, when thousands of Missouri college parents will have to decide: To get their child vaccinated, or not. Research shows that up to 80 percent of college cases can be pre-vented by the vaccine, according to federal health officials. The disease most often strikes people ages 15 to 24. The new law takes effect this

The vaccine is not cheap. It can cost anywhere from \$60 to \$90, four or five times more than the cost of a routine flu shot, and some insurance policies don't

Stressed Seniors Seek Higher Studies

Graduating seniors have a task of several things to accomplish before graduation: from ordering class rings, to scheduling senior pic-tures, getting fitted for cap and gown, and for some, this includes wor-rying about the deadline for graduate school applications. Director of Career Development, Ellen Weaver-Paquette, noted that surveys conducted in 2002 and 2001, indicated that more students were leaving Rhode Island College and going right to full time gradu-ate school. She also pointed out that "recent trends have shown that a significant number of liberal arts students are going to graduate erboal." school."

school." "Forty-three percent of the class of 2002, not seeking full time employment sought full time graduate studies," continued Paquette. She called this "a very healthy percentage." Due to this "big jump", she felt that the college needed to provide undergraduate assistance to help prospective graduate students. The first graduate fair to be held on the Rhode Island College campus took place in the Student Union Ballroom on October 29. This fair gave BIC students a chapter to get an insight into the graduate

fair gave RIC students a chance to get an insight into the graduate world by speaking with various representatives from over thirty college

Many careers require students to go further with his or her educa-tion and to pursue a master's degree. Examples of such fields include teaching and psychology.

Since application deadlines for fall graduate admission falls any-where between February and April, many seniors' Christmas breaks became "Christmas Heck." While some students were relaxing after opening gifts and taking the tree down, prospective graduate students were routinely checking the mail for his or her transcripts to arrive, figuring out GPAs and cramming for the graduate record examinations or the GRE's.

Financial aid deadlines for the FAFSA and merit or domestic aid

Financial aid deadlines for the FAFSA and merit or domestic aid are crucial to the student since the amount received often weighs heav-ily upon the decision of whether or not the student can afford to go there. Some graduate schools such as Emerson College or Boston University can cost as much as \$30,000 for a two year program. Financial assistance plays an important role in design-making, for the unemployed, just out of school graduate. Students are allowed to take the GRE's more than once, and have the choice to cancel scores or send them to the colleges of his or her choice. There is several software and online tutorials to assist the studying student. An important detail to remember is that the paper-based GRE test, which is only offered on a selective set of dates throughout the year, has a different set-up than the computer-based test. Students are advised that the studying methods for each are not transferable. methods for each are not transferable.

Enough said.


5. I will read an issue of the Anchor.

College Prep Myths

Top 10 myths about prepar-

ing for and attending college: The Bridge Project at Stanford University compiled a Stanford University complete a list of the top 10 myths students believe about college for its recent report, "Betraying the College Dream." The national report included feedback from students, parents and educators in six states

_I can't afford college: Students and parents regularly overestimate the cost of college.

_I have to be a stellar athlete or student to get financial aid: Most students receive some form of financial aid.

_Meeting high-school-grad-uation requirements will prepare me for college: Adequate prepa-ration for college usually requires a more demanding cur-riculum than is reflected in minimum high-school-graduation requirements, sometimes even if that curriculum is termed "college prep.

_Getting into college is the hardest part: For most students, the hardest part is completing

have academic standards: Students usually must take place-ment tests at community colleges ment tests at community colleges to qualify for college-level work. __It's better to take easier classes in high school and get better grades: One of the best predictors of college success is taking rigorous high-school classes. Getting good grades in lower-level classes will not pre-nera students for college-level pare students for college-level work.

_My senior year in high school doesn't matter: The class-es students take in their senior year will often determine the

year will often determine the classes they are able to take in college and how well prepared they are for those classes. __I don't have to worry about my grades, or what classes I take, until my junior year: Many col-leges look at sophomore grades, and, in order to enroll in college-level courses students need to level courses, students need to

cover the cost. So some students might not get the shot. This week at Pittsburg State, students will be allowed to charge the shot to their university account and pay it off in installments. The vaccine is effective against four of the five most

against four of the five most common strains of the disease in the United States, according to the American College Health Association, a national non-profit group working with the Centers for Disease Control and Prevention to spread the word Prevention to spread the word about meningitis risks on college campuses. Local college health offi-

cials have long offered the vac-cine through their student health clinics. At Pittsburg State, the vaccination has been offered on campus the last three years and students moving into residence halls get information about the disease in their information packets. The University of Kansas

began putting meningitis information into new-student packets several years ago, too. And uni-versity health officials attend freshman orientation during the summer where they can answer questions from students and parents, and even give the shot on the spot, for a fee.

But they wish more stu-dents would heed the advice.

Sometimes it takes reported cases like the ones in Pittsburg to drive the message home. "As college health physi

"As college health physi-cians we always have that in the back of our minds," said Myra Strother, chief of staff at KU's Watkins Memorial Health Center. "It's a very hard thing to diagnose. You always have to have that mind-thought to be looking for it." looking for it." The cases in Pittsburg

touched off a frenzy of activity around Christmas. County health officials informed the school of the two cases, reportedly the first-ever on the cam-pus, on Dec. 23. The news touched off a

The news toucned off a quick, orchestrated effort to tell students who had already left campus. "The timing couldn't have been worse," said Ron Womble, director of the school's news services and medic acletions. media relations. Both students lived in

Trout Hall, one of the smallest of the university's six dormitories. College officials, assisted by the Crawford County Health Department and the Kansas Department of Health and Environment, gathered informa-tion to give students.

Then 20 volunteers spent Christmas Eve phoning the prepare well for college. This means taking a well-thought-out

means taking a well-thought-out series of courses starting no later than ninth or 10th grade. _I can't start thinking about financial aid until I know where I'm going to college: Students need to file a federal-aid form before most colleges send out acceptance letters. This applies to students who attend communi-ty colleges: too. even though they ty colleges; too, even though they can apply and enroll in the fall of the year they wish to attend. _I can take whatever classes

I want when I get to college: Most colleges and universities require students to take place-ment exams in core subject areas. Those tests will determine the classes students can take.



dation letters. These letters, often rate an individual's communication skills and/or personal and professional strengths and weaknesses. The essays are also important because they give the student a chance to present his or herself, in addition to the paper application.

A few graduating seniors and a RIC alumni noted that when applying to grad school you are simultaneously applying for stress and working against the clock. Anchor alumni and former Anchor staff writer Ann-Marie Piantadosi, now a student in the Broadcast Broadcast Journalism Department at Emerson College, reflected upon her experience with applying to a grad school. "I found that applying to graduate school was fairly stressful, especially when trying to make sure my references had finished writing my recommendation letters. I didn't want to come off as a pain, but I also wanted to make sure the letters were submitted on time

Piantadosi added that a lot of recent college graduates cannot find jobs, since the job market is currently "very tough". "I feel that the time and energy one puts into applying to graduate school ito apprying to graduate school is worth it, especially during these times," continued Piantadosi. "If the job market was in better shape, I'd be work-

ing now," she concluded. The factor of distance does n't limit some prospective gradu-ate students. Senior and Anchor Editor Jamie Pachomski, drove Editor Jamie Pachomski, ulove 18 hours to Chicago, Illinois over holiday break to visit the school of his choice, Roosevelt University. "I made sure they had

University. "I made sure they had my transcripts and application prior to my visit so they could see I was ready to talk business," stated Pachomski. He offered advice to other seniors seeking higher studies. " The bottom line is graduate schools want adults. My advice is go in style, be selective and carry yourself well," concluded Pachomski.

"We didn't have panicky people and we didn't have pan-icky parents," said Womble. "That was a concern: Will they understand?' We gave them good information, and I think that helped allay fears." Janis Goedeke, health officer for the Crawford County Hadth Dencertment in Pittshurg







How To Spot A Liar

Liars. If there is one thing in this world that I hate it is a liar! To me there is nothing worse. Are they repeating the statement, rather than answering? Do they keep saying "I am telling you the truth" or "I wouldn't lie to you"? Are they accusing (Are you saying I am lying?), stammering, stuttering, and pausing before answering? These are all sure fire signs that the person you are talking to is lying. These signals are even more dependable than body language. When a person is not telling the truth they need the time to make up the lie and these ploys buy time so that their brain can come up with something viable to tell you. It is almost like they are writing a story and when they do finally answer, chances are that most of the facts will be unverifiable. After all, why would the liar want you to be able to check the facts, unless they are an idiot







We cannot know the mis-takes of the future, lest we be damned to make them. Always pay mind to who we are and what we've done for

With writing like this, Dick creates a different sort of science fiction. The focus is less on the fiction, and more on the science. What science, you might be ask-ing? The science of humaniis the focus. The emotions behind what we do are examined. How does one react when they know when they are going to die? Is a man with no past really a man? These questions are not what to look at, but what emotions these questions make rise. He will certainly leave you with a bit to think about

For a film with an interesting mentality, give due to Paycheck. It's an experience that will give you not only a rush of adrenaline, but also a new take on some of you actions. After all, is it really worth only remem-bering the good parts of this movie?

This week, we look at a lesser-known anime named Kazemakase Tsukikage Ran, or "Wind-born Moon-lit Ran". It is a 13 episode series avail-able in its entirety on 4 DVDs from Bandai Entertainment under the name Carried by the Wind: Tsukikage Ran. Tsukikage Ran is a series

featuring two main charac-ters: Ran, a wandering female Samurai with peerless sword skills, and her sidekick, a ditzy martial artist named Meow of the Nekotekken (Iron Cat Fist). Ran is a typical vagabond Samurai – she wanders aimlessly around the country, eats simple food, guzzles down Sake like there's no tomorrow, and has a strong sense of Justice and will right wrongs when she encounters one. Meow is a typical sidekick character – ditzy, kind of stupid, very brash and active, and is always quick to jump in and try to do the right thing (sometimes with disastrous results). The two drift around Japan, having small adven-tures. The series is episodic, with no link between any two episodes, really. Almost every episode follows a very stan-dard format: One of our heroines arrives at a town, and meets the other at a restaurant or bar or something. At some point, they find out about some wrong occurring. Meow gets somehow tangled up in the situation, and Ran comes and resolves it all with her sword.

Tsukikage While While Tsukikage Ran aired in 2000, it has the feel of a much older show. It is very reminiscent of a classic 50's black and white samurai drama, except animated, in color, and with female main characters. It has a gentle, strolling pace to it – it is never rushed, but is never really slow and bogged down either Ran slow and bogged down either. The music is traditional sounding Japanese music, while it may not be to every-body's taste it is nice and fits the mood of the show per-fectly. My one complaint fectly. stupidity. The origin of the name of the language lies in the word elite. Elite is easily abbreviated to leet. It is not hard to see how that can be further mutated into 133t, since a 3 looks like a mirror imaged uppercase E. Finally, I looks like the number 1 in many fonte ond a 7 is not too disfonts, and a 7 is not too dis-similar from a poorly written uppercase T, leaving us with 1337. Most words in 1337 are generated this way. For example, \$p34|< means "speak." S becomes \$, e becomes 3, A becomes 4, and K becomes |<. Fairly straight-forward |< right? forward, Pronunciation is also often used to modify words into 1337. For example, the word "you." Rather than becoming "you" as one might expect, the "u" sound is rendered into "oo" or "oo" so that you is translated into joo. Another example of this is the translation of the word dude into dood. F is usually rendered into ph – you don't "fear" an opponent, you "ph33r" him.

Similarly, I is often rendered as "3y3" for "eye." This can cause confusion, but 1337 is not meant to be straightforward and easily useable any-

way. There are also specific rules for how certain words are translated. One of the more commonly used words in 1337 is "pwned." Pwned is used in context to mean domused in context to mean domi-inated or completely defeat-ed, as in, "dood, joo got pwned!" The origin of this derives from the word "owned" which was used to mean dominated. When typmean dominated. When typ-ing rapidly, pwn is a common typo for own. Eventually, pwn and pwned became the official 1337 versions of own and owned. Another example of a 1337 word derived from a common typo is pron for porn.

Believe it or not, 1337 actually has some basic grammar. In general, verbs that do not end in "ing" are mutated with a or. For example, "I will hack you" is "3y3 wi11 h4xor joo!" The exact same word joo! may be used to replace a noun representing the person noun representing the person who performs such an action, that is, a hacker is also a h4xor. When a word is plu-ralized, generally a z is appended instead of an s. For

example, skills become \$ < i112.


Throughout this article, I Throughout this article, I have been using "medium" 1337. There are varying degrees of usage, distin-guished by how warped your words are. Light 133t is essen-tially readable without stress once you are in the know, with only a few substitutions. with only a few substitutions. Medium 1337 requires a bit more thought, but is still fairly readable.
